

<u>Appointment of Andrew Wilkinson</u> <u>completes country leadership team for ISS</u> <u>UK & Ireland</u>

ISS UK & Ireland (ISS UK&I) has announced the appointment of Andrew Wilkinson as Chief Operating Officer (COO) of its Office & Production business unit. Andrew will assume the role on 1 September 2022, following an orderly handover with Kevin Wildman, who has been in role on an interim basis since 1 January 2022.

The Office & Production business unit is primarily responsible for ISS UK&I's private sector clients, including the banking, professional services, technology and production industries and its entire Ireland operation, which is based out of Dublin.

During his time at Sodexo, Andrew also held operational,



strategic, and marketing roles in the Corporate Services segment.

Kevin Wildman will step down from his interim role as COO of Office & Production on 31 August 2022, having acted as custodian of the unit for eight months during the recruitment process for a permanent appointee.

This includes roles as director of business improvement at supply chain specialists, Wincanton, and a range of leadership roles at Serco (including Managing Director of Serco, Europe).
