As well as providing access around the property, fire doors are a critical part of the fire compartmentation requirement. New regulations being introduced to the Regulatory Reform (Fire Safety) Order 2005 (Fire Safety Order) contain a requirement for responsible persons in buildings above 11 metres in height to provide additional safety measures.

This includes things such as providing occupants with fire safety instructions and information on the importance of fire doors. Responsible persons will also be required to undertake annual checks of entrance doors and guarterly checks of all fire doors in common parts.



Brian adds: "Our Fire Door Guide has been created to offer guidance on specifying, installing, maintaining and inspecting fire certified doorsets in residential and commercial buildings, and we hope that it can help raise industry standards and provide greater awareness.
