

Mace, Turner & Townsend and Atkins team secure place on £5.1bn defence estate optimisation framework

A consortium of Mace, Turner & Townsend and Atkins (MTA) has been appointed by the Ministry of Defence as a Technical Service Provider on its Defence Estate Optimisation Portfolio framework.

With the appointment – recently confirmed at a signing ceremony with senior delegates – the three firms will operate as a single, coordinated team, supporting the Ministry of Defence (MoD) to develop, construct and integrate value for money solutions in the West of England and Wales region.

Defence Estate Optimisation (DEO) is the single biggest estates change programme within defence, bringing together an ambitious portfolio of interdependent programmes, construction activity, unit and personnel moves, and land release. It will invest £5.1bn in a better-structured, modern and more sustainable estate that improves security, resilience, and military capability.

The Mace-led team will provide design assurance and construction management services for this critical infrastructure portfolio as a sole supplier across the West of England and Wales region.

The trio, which already serves as delivery partner on the US Visiting Forces Infrastructure Programme at RAF Fairford in Gloucestershire and RAF Menwith Hill in North Yorkshire, will work to the Defence Infrastructure Organisation (DIO), the part of the MoD that will oversee the framework.

Baroness Goldie DL, Minister of State for Defence in the House of Lords, said: “The Estate Optimisation portfolio is fundamental to the future of Defence. From service, and family living accommodation, to specialist facilities such as hangars, command headquarters and medical facilities, this is the largest and

most ambitious Defence infrastructure investment portfolio that we have as a department. At the heart of this is making life better for our people.

“I am proud of the hard work that has gone into establishing these two contracts which are central to this programme’s successful delivery. This is a once in a generation opportunity to deliver significant change, and I for one am delighted to sign on the dotted line.”
