The [British Cleaning Council \(BCC\)](#) has thanked the more than 450 industry members who have so far backed its campaign to make cleaning and hygiene a national priority.

It comes as a new assessment rating the likelihood of a pandemic in the future shows how important it is that the Government takes the measures being demanded in the campaign.

The recently published National Risk Register, ranked the chances of a future 'catastrophic' pandemic as up to 25 per cent.

BCC Chair Delia Cannings said: "I want to say a huge thank you to everyone who has backed the campaign so far. But if you haven't, please do take part. It is literally a matter of life and death and it should only take a few minutes to get involved."

The government has announced it is acting to bring forward changes to regulations that will mean all new non-domestic public and private buildings will be required to provide separate single-sex toilets for women and men and/or a self-contained, private toilet as a minimum.

The change comes amid dignity and privacy concerns from women and elderly people who feel they are

being unfairly disadvantaged as publicly accessible toilets are increasingly being converted into gender neutral facilities.

Kemi Badenoch, Minister for Women and Equalities, said: “It is important that everybody has privacy and dignity when using public facilities. Yet the move towards ‘gender neutral’ toilets has removed this fundamental right for women and girls.

“These proposals will ensure every new building in England is required to provide separate male and female or unisex facilities, and publish guidance to explain the difference, protecting the dignity, privacy and safety of all.”
