[Sodexo UK & Ireland](#) has announced its net zero supply chain engagement strategy, and stated that from January 2030 it will only work with suppliers demonstrating tangible progress through published reporting.

The food services and facilities management business was one of the first organisations to have its UK and Ireland net zero 2040 target validated by the Science Based Targets initiative (SBTi). The organisation has been transparent about its [net zero journey](#) and progress, including the fact that just 2% of its emissions sit in Scopes 1 and 2 – in the direct control of Sodexo UK & Ireland. Of the remaining 98% of its total emissions, 34% sit within its supply chain.

While Sodexo is being very clear with its supply partners about expectations, the business is also offering considerable support where these organisations are experiencing challenges, to help them complete the work needed to hit the milestones.

Aoife Wycherley, Head of Supply Chain, Sodexo, UK & Ireland said: “We are so proud of the extensive and diverse supply chain we have built – we genuinely work with some incredible businesses, big and small. Their response to this challenge and to our offer of mentoring and other support has been positive and we feel confident that this roadmap will deliver ever more impactful reductions in emissions.”
