## Fire hazard: Cheap plastic living walls could cost you your business and more

"Unless you can guarantee that your living wall is flame retardant, your insurance will not cover it either, and you are putting the people using your building at risk as well as breaching your health and safety obligations."

Replica living walls are often used as an alternative to real living walls in interior spaces where low light or the environment may not allow real plants to thrive. Research has shown that both real and replica living walls bring huge benefits to those who use the space around them, including improvements in general well-being and mood and greater productivity.



"Good quality replica living walls, like the ones supplied by phs Greenleaf, are life-like, long-lasting and – crucially – flame retardant," says Stephen Dieppe.
