- The opportunity to deliver circular economy solutions in North America is significant – the region produces 10x more waste than the UK, yet has linear resource chains, low recycling rates and an over-reliance on landfill and incineration. In 2023, approximately 300 million tons of municipal solid waste was generated, of which only c.35% was recycled<sup>1</sup>
- The circular economy market was valued at USD 556 billion in 2023 and is projected to reach USD 1.32 trillion by 2030, growing at a CAGR of 13.2%<sup>2</sup>
