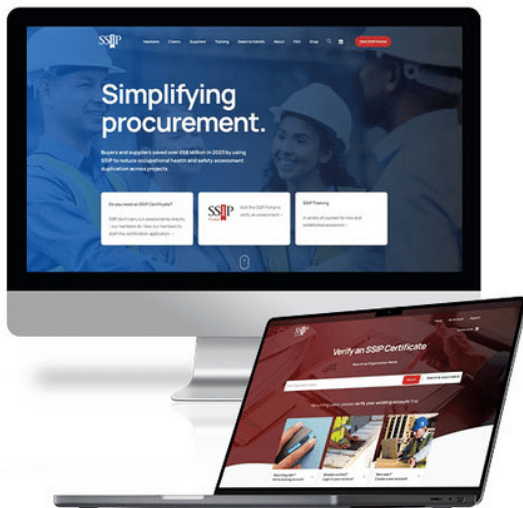


# Streamlining Safety: Why Buyers Should Stipulate SSIP Certification for Suppliers
