For facility managers, this translates into simpler project management and more predictable outcomes.



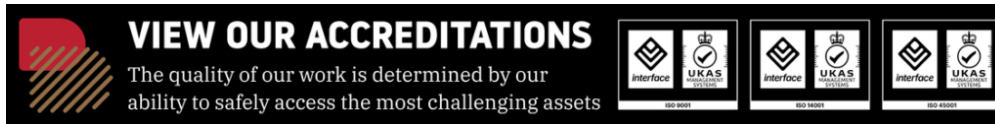
